

KLAMATH COUNTY COMMISSIONERS NOTICE OF EXECUTIVE SESSION

The Klamath County Board of Commissioners will hold an Executive Session Tuesday, August 8, 2017 at 10:00 a.m. in the Government Center conference room #214 located at 305 Main St., Klamath Falls, OR. This executive session is being held pursuant to the following Oregon Revised Statutes:

- ORS 192.660(2)(e) to conduct deliberations with persons designated by the governing body to negotiate real property transactions.
 - Possible property purchase
- ORS 192.660(2)(h) to consult with counsel concerning the legal rights and duties of a public body with regard to current litigation or litigation likely to be filed.
 - Fair Board litigation
 - Opioid lawsuit
- ORS 192.660(2)(f) to consider information or records that are exempt by law from public inspection pursuant to ORS 40.225 lawyer-client communications regarding:
 - Dog hearing procedure follow-up

Representatives of the media are prohibited from reporting on any of the deliberations during this executive session, except to state the general subject of the session as stated above.
