Consideration, on remand from LUBA, of a request to approve an exception to Statewide Planning Goal 4 to allow the development of a facultative lagoon storage and the reuse of effluent to irrigate forested land or a field of forage, and approval of a limited use overlay to restrict the use of the property to only that described above. The 15 to 16 acre facultative lagoon storage will consist of three cells: Cell 1 will be 9.1 acre and used for storage, Cell 2 will be 3.7 acre and used for primary treatment, and Cell 3 will be 2.47 acres and used for secondary treatment. Chlorine will be used to disinfect the effluent. Then the effluent will be pumped to a sprinkler system to irrigate either a 32 acre field of forage crop or 40 acres of forested land. The entire project will impact 120 acres of the 211 acre property. The subject site is located on the north side of HWY 422 approximately ½ mile west of HWY 97.
