<p><i>A nonpartisan office that becomes vacant due to retirement, resignation, recall or death, and the vacated office would not normally be printed on 2022 ballot, must be elected at the General Election, and the following rules apply:</i></p> <p><i>If 1 or 2 candidate(s) file they are both considered nominated and go forward to the General Election and their name(s) will be printed on the General Election ballot. The candidate(s) name(s) will not appear on the Primary Election ballot.</i></p> <p><i>If three (3) or more candidates file, their names will be printed on the Primary Election ballot. If one (1) candidate receives the majority of votes that candidate is nominated and his/her name will be printed on the General Election ballot. If no candidate receives the majority of votes the top two (2) vote getters will go forward to the General Election and their names will be printed on the General Election ballot.</i></p>					

County Commissioner Position 2	18	Resident of county one year prior to election.	4 years	This is a nonpartisan position with the passage of Measure 18-90.	County governing body appoints qualified person until successor is elected.
<p><i>This office can be won at the Primary Election if; only one (1) candidate files for this office in the Primary or two (2) or more candidates file for this office and one (1) receives the majority of votes. (50%+1)</i></p> <p><i>A candidate will be nominated at the Primary Election and go forward to the General Election if; two (2) or more candidates file for this office and no one receives the majority of the votes at the Primary. The top two (2) vote getters are then nominated to go forward to the General Election.</i></p>					

Assessor	18	Resident of county one year prior to election.	4 years	Must be registered appraiser or appraiser trainee and have two years accounting experience or two years employment in appraiser's office. Must be certifide to be eligible by Dept. of Revenue	County governing body appoints qualified person until successor is elected.
<p><i>This office can be won at the Primary Election if; only one (1) candidate files for this office in the Primary or two (2) or more candidates file for this office and one (1) receives the majority of votes. (50%+1)</i></p> <p><i>A candidate will be nominated at the Primary Election and go forward to the General Election if; two (2) or more candidates file for this office and no one receives the majority of the votes at the Primary. The top two (2) vote getters are then nominated to go forward to the General Election.</i></p>					

Justice of the Peace	18	Resident of state 3 years and residence or office in district one year prior to appointment or becoming a candidate.	6 years	If not a member of the state bar, must take 30 hours of continuing education every 2 calendar years.	Governor appoints qualified person to serve until successor is elected.
<p><i>This office can be won at the Primary Election if; only one (1) candidate files for this office in the Primary or two (2) or more candidates file for this office and one (1) receives the majority of votes. (50%+1)</i></p> <p><i>A candidate will be nominated at the Primary Election and go forward to the General Election if; two (2) or more candidates file for this office and no one receives the majority of the votes at the Primary. The top two (2) vote getters are then nominated to go forward to the General Election.</i></p>					

Clerk	18	Resident of county one year prior to election.	4 years		County governing body appoints qualified person until successor is elected.
<p><i>If 1 or 2 candidate(s) file they are both considered nominated and go forward to the General Election and their name(s) will be printed on the General Election ballot. The candidate(s) name(s) will not appear on the Primary Election ballot.</i></p> <p><i>If three (3) or more candidates file, their names will be printed on the Primary Election ballot. If one (1) candidate receives the majority of votes that candidate is nominated and his/her name will be printed on the General Election ballot. If no candidate receives the majority of votes the top two (2) vote getters will go forward to the General Election and their names will be printed on the General Election ballot.</i></p>
