**3. What part of your marketing efforts were most successful and least successful?**

Visitors often pointed out that they saw our ad in one magazine or another (which accounted for most of our budget)—especially 1859 and Southern Oregon Magazine. Discover Klamath handled our social media. Reports they received regarding their campaign indicated it was successful. For all the dollars we spent on marketing, probably the most significant contribution to our overall success was a full page article about Edward Curtis and our exhibit that ran in the Medford Tribune—submitted by local writer Lee Juillerat. It included several captivating Curtis photographs. We had many visitors from the Rogue Valley this summer. Although Rogue Valley visitors do not generally spend the night (per the mission of the grant program), their response to the exhibit, and their interest in the Favell Museum was overwhelming and gratifying.

**4. How many people from out-of-county attended?**

Nearly 2000 people paid to visit the museum during the run of the Edward Curtis exhibit. Although we did not track where people were coming from, it is safe to say that at least 90% of them were from out-of-county—which is in line with our visitorship in general. Almost all locals visitors who come to the museum, do so with their own visiting friends or relatives.

**5. How did you determine how many people from out-of-county attended? Explain why this is an accurate measurement of the out-of-county attendees?**

I have been with the museum a long time, and I am aware of statistics regarding visitorship. We have a guest book. Our front desk keeps tabs on where people are coming from, by engaging in conversation. Aside from the uptick in summer attendance numbers, this summer was much the same as every summer. I am confident in my estimate.
